Development of the WCO Asia/Pacific 2022-2024 Regional Strategic Plan (RSP)

The RSP is designed to support the uplift of Members capacity and compliance with WCO objectives and help guide the Asia/Pacific Customs Region and its Members' priorities, needs and interests to meet future challenges

Endorsed at the 25th Asia/Pacific Regional Heads of Customs Administrations (RHCA) Conference in Sydney Australia on 18 April 2024, the 2024-2026 Regional Strategic Plan (RSP) sets out the Asia/Pacific Region's direction over the next two years. This clear articulation of strategy, objectives and key performance indicators is critically important to help guide the Region's common efforts, maintain clarity of purpose, and enable measurement of performance in a transparent manner.

VISION

"To be the leading WCO Region for Customs, through enhancing mutual growth, security, unity and prosperity by working collaboratively and effectively together."

MISSION

"To work collaboratively and cooperatively to continue to promote secure and facilitated trade, ensure compliance with and enforcement of Customs laws, and strengthen Customs capability and modernization."

The development of the RSP involved extensive collaboration and rigorous consultation across the Asia/Pacific Region, primarily through the establishment of an RSP Working Group of Members and Focus Area Co-coordinators, including: Australia; Bangladesh; the People's Republic of China; Hong Kong, China; Indonesia; Japan; the Republic of Korea; New Zealand; the Philippines; Thailand; and Vietnam. The RSP Working Group met virtually four times and frequently undertook intersessional consultation and collaboration to develop a robust product reflective of the Region and its Members' priorities, needs and interests.

Some of the key updates to the RSP include a new Focus Area on 'Resilience and Transformation', an updated reflection of the WCO Environmental Scan (July 2021 Update) that reflects the post-pandemic environment and settings, greater alignment with the WCO Strategic Plan, and the ongoing efforts towards the Organization's modernisation and reform.

RSP FOCUS AREAS

FA1: Trade Facilitation & Security – Co-coordinators China and Korea

FA2: Compliance & Enforcement – Co-coordinators Hong Kong, China and RILO A/P

FA3: Capacity Building – Co-coordinators Japan and ROCB A/P


FA4: Resilience & Transformation – Co-coordinators, Australia and Vietnam

The corresponding RSP Terms of Reference (ToRs), which were also endorsed at the 25th RHCA, provide the Region, the incumbent Asia/Pacific Vice-Chair and Asia/Pacific WCO Members guidance and recommendations on the responsibilities, processes, timelines and other considerations for the development of the biannual Asia/Pacific RSP and establishment of the RSP Working Group that help support its development.

Members were advised at the annual Asia/Pacific Regional Consultations at WCO Council in June 2024 that the 2024-26 RSP and the RSP Terms of Reference – that were recently endorsed at the 25th RHCA – were published and available online.

The annual Regional Consultation for the Asia/Pacific, held in Brussels in June 2024, provided Members an opportunity to discuss issues of significance to the Region on the agenda for WCO Council. It also gave time to de-brief on key outcomes of the 90th Policy Commission, recap key moments from the 25th Regional Heads of Customs Administrations Conference, and reflect on the contributions the Asia/Pacific has made over the past two years. Members also focused on the key issues of WCO Modernization and considerations for organizational arrangements, process for appointment of Directors, and the WCO Modernization Implementation Plan.

Outgoing WCO APVC Michael Outram APM, Australian Border Force Commissioner and Comptroller-General of Customs, expressed his appreciation and thanks for Members' support and engagement during his tenure. He reflected on some of the many achievements of the Region during that time, including: the Resolution on Customs-Industry Resilience; the Regional Communique on Gender Equality and Diversity; the establishment of a number of new Regional Training Centres; emerging efforts on illicit tobacco, Smart Customs, supply chain integrity; and, continued capacity building activities. Commissioner Outram said it was an honour to have served as APVC, which he noted was both a high point and the culmination of his Customs career.

Members also welcomed Commissioner Ho of Hong Kong Customs as the next WCO APVC and confirmed the regional representatives on WCO Committee positions, while those concluding in their tenures were thanked for their commitment and dedication. Of note, the additional seat afforded to the Asia/Pacific on WCO Committees with the Region's increase in Membership is significant as it allows the Asia/Pacific a greater voice to influence and further represent the diversity of the Region, and that reflected within the WCO. It provides for greater consideration of the Region's perspectives, from small island economies and the unique Customs priorities and needs of their administrations to those developed and developing economies with some of the largest administrations within the WCO and their proactive efforts and initiatives at the forefront of Customs.

In a short ceremony, Commissioner Outram handed over responsibilities to the incoming APVC, Commissioner Hong Kong Customs, Ms Louise Ho, wishing her, her Office, the Region and Members the best for the years ahead. Commissioner Outram noted he had every confidence in Commissioner Ho maintaining the Region's engagement and efforts going forward and to further support the growth, security, unity and prosperity of the Asia/Pacific Region.



The WCO Resolution on Strengthening Customs-Industry Resilience


Members reflected on the passage of the Resolution at the annual Regional Consultations at WCO Council in June 2024 and the significant work undertaken by the Asia/Pacific Region, by Customs and Industry, to develop and drive the initiative.

In June 2024, the WCO Council endorsed the Resolution on Strengthening Customs-Industry Resilience, which was developed as a collaborative initiative stewarded by Australia as the WCO APVC. The Resolution embeds the permanency of resilience at the core of the Customs-Industry partnership, committing all 186 WCO Members and inviting Industry partners, namely the Private Sector Consultative Group, to achieving the aims and objectives of the Resolution. The Resolution was developed from the foundation laid by the Asia/Pacific-led Concept Note on 'Strengthening Customs-Industry Resilience', which stemmed from a bilateral engagement in March 2023 between ABF Commissioner Outram as the APVC for 2022-2024 and Mr Kit Hickey, Chair of the Asia/Pacific Regional Private Sector Group. The Concept Note was well received by the Region, along with the then WCO Secretary General Dr Kunio Mikuriya and the broader WCO Membership, who supported the evolution of the Concept Note into the Resolution.

The Resolution recognises that Customs-Industry resilience is a pillar of global security and prosperity, which cannot be achieved in isolation, in an age of transformation and unprecedented global challenges. Customs' innovative 'engagement with traditional and new partners with purpose' is critical to achieving a connected border system that is not only seamless in trade facilitation but also secure, resilient and impervious to new and emerging threats. Noting Customs' critical role during periods of global disruption, the Resolution also encourages Members to review and develop robust business continuity plans, enhance digitalisation through the adoption of secure paperless trade practices, and look to the future through strengthening relationships with Authorized Economic Operators (AEO) and identifying the benefits of AEO programs. The Resolution is a response to the growing need to continue and strengthen the collaboration between Customs and Industry as trusted partners, integral to achieving resilience.

In February 2024, The Regional Intelligence Liaison Office - Asia/Pacific celebrated its Official Opening in Tokyo



In January this year, host Member of the Regional Intelligence and Liaison Office – Asia/Pacific (RILO A/P) transferred from South Korea to Japan, with a new Office opened in Tokyo. In February, the RILO A/P Tokyo Office held its opening ceremony, followed by a two-day Regional High-Level Roundtable organized by the World Customs Organization (WCO). The event was attended by high-level participants of Customs administrations from the Region, WCO Secretary General Ian Saunders, former Secretary

General Dr Kunio Mikuriya, and many other representatives from relevant international organisations and law enforcement agencies. From Japan, State Minister of Finance Katsuo Yakura attended, and a video message from Prime Minister Kishida was shown at the beginning of the ceremony, expressing strong support from the Government of Japan for the RILO A/P and its regional efforts. The event was a great success and a significant boost for RILO A/P's future endeavors from its Tokyo Office.

There are 12 RILO Offices around the world, but the RILO A/P has the largest membership, with 35 Asia/Pacific Members. RILO A/P also has the largest number of dedicated staff seconded from the Region with: six from Japan Customs; two from Korea Customs Service; and one from Hong Kong Customs. Two additional Customs officers from China will also join soon. The RILO A/P is planning to establish several technical assistance programs to allow many Customs officers from the Region to work in the Tokyo office, with the hope these programs will attract more staff to rotate through the RILO A/P Office over its time in Tokyo.

Although the RILO A/P is already one of the largest of the WCO's regional entities, it continues to grow with the support of its Members and the interest

and value they place on its products and services. Like other RILO Offices, the basic function of RILO A/P is to help its Members to strengthen their efforts to control smuggling and combat criminal groups by collecting, analyzing, and sharing information on smuggling. This information may be shared immediately or with accompanying analysis, depending on what is most useful for Members. In recent years, criminal groups attempting to smuggle goods have increased and expanded their networks. To combat this effectively, it is imperative that Customs administrations also develop a broad and effective network with each other.

The RILO A/P's Mission is to connect people from different backgrounds. The RILO A/P is working to ensure that Customs, law enforcement agencies,

international organisations, and private bodies are all well-connected.

The RILO A/P is steadily performing these core tasks while also taking on new projects. For example, we are working on more efficient ways to collect data on Customs seizure cases at the regional level, streamlining procedures to eliminate unnecessary duplication and increase efficiency of regional operations, and establishing specific cooperation with private sector and relevant international organisations. Accepting staff from developing Member Customs administrations is another new initiative the RILO A/P is now planning, in order to help uplift the capability of the Region. The RILO A/P is able to tackle these unprecedented projects thanks to the strong support of Japan Customs and Members of the Asia/Pacific Region.

The RILO A/P is an organisation committed to supporting the Asia/Pacific Region. We carefully consider the information and the analysis we share, as well as the new projects we undertake, to ensure they align with the needs of our Members and the challenges they face. We greatly appreciate receiving Members' requests and the continued support provided to advance the work and relevance of the RILO A/P.

Finally, the RILO A/P wishes to highlight and welcome new staff, whether for short term placement or for longer secondments. Individuals may join as staff for various reasons such as to enhance regional smuggling intelligence efforts; train young professionals, or implement a specific project using the RILO Tokyo office.

Dear Members, together, we advance!

Throughout its 20 years to date, the ROCB A/P has been committed to supporting Members' modernisation efforts by organising WCO Workshops, raising the standard of Training Management across the Region, supporting Members to establish Regional Training Centres and organising regional engagements to ensure our strategic relevance.

However, firstly, we at the ROCB A/P must take this opportunity to express our sincerest gratitude to the Thai Customs Department for their exceptional ongoing hospitality and commitment by hosting the ROCB A/P, as well as to Member Customs administrations for their contribution of very capable attachés in support of our efforts, including: China; Hong Kong, China; Japan; and Korea.

The 2024-2026 Regional Strategic Plan (RSP) for the Asia/Pacific Region, adopted at the 25th Regional Heads of Customs Administration Conference in Sydney, Australia in April, 2024, tasked the ROCB A/P to implement specific actions in its Work Plan, in close cooperation with the Office of

the Vice-Chair and Members of the Region. These specific actions emphasise capacity building activities in the Region and seek to maximise our collective efforts on focused and results-oriented activities, while also ensuring the effective use of limited resources. These actions include further efforts to improve the quality of capacity building activities by reflecting on Members' needs and priorities and providing a good value proposition. This remains the focus of the new leadership of the ROCB A/P.

In Financial Year (FY) 2023-2024, the WCO successfully conducted over 50 capacity-building activities in the Asia/Pacific Region, including at the Regional, Sub-Regional, and National level. The ROCB A/P has supported a number of these activities, in a Region where we are fortunate to enjoy a wealth of resources, thanks to the financial support of Member funding, primarily from China, India, Japan and Korea.

In order to ensure more effective programme delivery, the ROCB A/P is orienting its efforts to design workshops tailored to Members' specific-needs. In order to achieve this, the ROCB A/P tries to better understand Members by collecting information on their policy priorities and current situation, such as during returns of the Annual Needs Survey, which is undertaken in cooperation with fellow RSP Co-coordinator Japan Customs for Focus Area 3 on Capacity Building, This allows the WCO and the ROCB A/P to identify a targeted agenda and the means to address current challenges. In addition, the ROCB A/P conducts post-workshop engagements, summaries and reports to help participants and beneficiaries to better understand the content covered while also collecting postevent Action Surveys for participants to encourage feedback on follow-up actions.

ROCB A/P activities have mainly supported training and workshops to respond to Members' collective needs. However, the

ROCB A/P also supports project-based activities, which are becoming increasingly popular. Projects are conducted by specialised teams, and are designed to cover specific needs of a select cohort of Members over a multi-year timeframe. Recently, the ROCB A/P initiated a Project on Training Management Project over a twoyear period, based on Regional needs and funded by Japan Customs Cooperation Fund (CCF/Japan) and in close cooperation with the WCO Secretariat, conducting several Workshops throughout the Region. The result of these activities were then compiled in the Training Management Compendium. scheduled for release in 2025.

The ROCB A/P also supports the multiyear activities of the WCO Master Trainer Programme, in cooperation with the Japan International Cooperation Agency (JICA), on Customs Valuation and Harmonized System (HS) Classification, This Programme supported a select number of participants with training to become 'Master Trainers'. This Programme has recently concluded with many participants having completed their training and already playing a pivotal role in their home Customs administrations in the Pacific Sub-Region. Moreover, many of them have also successfully completed Pre-Accreditation Workshops focused on their respective areas of expertise.

The ROCB A/P also made significant contributions to a joint-effort of respective donor organizations. The WCO-UNESCAP UNNExT Master Class was organised by the WCO, the United Nations (UN) Economic and Social Commission for Asia and the Pacific (ESCAP) and the UN Network of Experts on Paperless Trade and Transport (NExT), in March 2024 and funded by Korea Customs Cooperation Fund (CCF/Korea) and the Ministry of Economy and Finance of the Republic of Korea. The programme offered unique opportunities to develop comprehensive knowledge and capacities for the implementation of effective trade compliance and facilitation measures.

Despite these accomplishments and a busy calendar of capacity building, further improvements toward delivery of higher quality capacity building activities are always kept in mind when designing training programmes, and always based on consideration and reflection of Members' needs and priorities.

As part of its commitment to contributing to the Region, the ROCB A/P will strive to





learn about the actual situations of the diverse cohort of Asia/Pacific Members. This includes establishing an ongoing close dialogue and better communications with Members so that the ROCB A/P can effectively support Members' work towards the WCO strategic objectives, which in turn help to support better targeted WCO activities. Moreover, in this era of scarce financial and human resources, it is important to also seek opportunities to cooperate and collaborate to deliver capacity building, including through jointefforts. This is important not only to avoid duplication but to also create synergies and remain relevant to Members' needs.

The ROCB A/P continues to play a crucial role in every stage of the WCO's Capacity Building Activities and sets an example for other regions to follow, whether from initial planning to management of the events on a daily basis and beyond, with post-event reviews and feedback.

All staff at the ROCB A/P work side-by-side with Members to achieve each respective Customs administrative goals. For that purpose, we humbly ask for and encourage Members' continued cooperation and collaboration. With our new leadership, we will work together, for a better future.

– Asia/Pacific (RPSG A/P) consists of 30
private sector companies drawn from across
the Region who provide the Asia/Pacific
Customs Region with business sector advice
and input on matters related to trade, supply
chains and border management.

The purpose of the Group is to improve understanding between Customs and the private sector, and to support the work program and priorities of the WCO, the WCO Asia/Pacific Vice-Chair and the WCO Private Sector Consultative Group (PSCG).

A key deliverable of the RPSG A/P is the ability to contribute knowledge and experience at the policy level, while at the same time providing practical advice on the operational impacts of policies on supply chains, border processes and business methodologies.

Members include companies from various industries and specialisations including manufacturers, exporters, importers, carriers, associations, customs brokers, logistics providers, etc.

With current geopolitical events including challenges to the global supply chain, cooperation between Customs, other border agencies and the private sector is more important than ever. Long-accepted business models and priorities based on efficiencies are being rebalanced to reprioritise resilience and to better manage uncertainty.

At the same time, the WCO is undergoing change with new leadership including a strong focus on organisational modernisation and reform to meet the future challenges that current trends foreshadow.



Regionally, the role of WCO Vice-Chair has shifted from Australia to Hong Kong, China and a new Regional Strategic Plan (RSP) for 2024-2026 has been developed.

In reflection of these changes and period of transition within the WCO and Region, the RPSG A/P has also undergone a period of refresh with a membership review and rotation of 14 new Members, including from four new Members from the Asia/Pacific not previously represented.

The Group's current priorities remain of ongoing relevance to the Region, including: Voluntary Disclosure, Free Trade Agreement; Rules of Origin/Certification, Digitalisation; E-Commerce; and, AEO/SAFE. However, current, and emerging challenges will compete, and in some cases are likely to take precedence in how the Group's interests are prioritised and evolve over time.

The RPSG A/P fully supports the Focus Areas of the new Asia/Pacific 2024-2026 RSP, including: Trade Facilitation and Security; Compliance and Enforcement; Capacity Building; and, Resilience and Transformation.

The Group views these as core Customs functions essential to enable a robust, secure, and efficient global supply-chain. Key elements for us within these Focus Areas include: Digitalisation; E-Commerce; Standardisation/Harmonization; and, improving the engagement of SMEs.

Two other areas of importance include:

Capacity Building – The RPSG-AP believes that joint capacity building provides an excellent opportunity for Customs and the business sector to better understand each other's operations and strategies – it is also where misunderstandings that make the supply chain less efficient can

be resolved. Currently, most WCO capacity building is Customs-to-Customs, and when considering that Customs biggest stakeholder is the trading sector, including ports, carriers, manufacturers, forwarders/brokers, banks, exporters and importers, etc., participation from the private sector is a valuable opportunity. It is the view of the RPSG A/P that both Customs and the business sector would benefit from a more inclusive WCO capacity building approach.

Cooperation with Other Government

Agencies – Cooperation is necessary to manage total government risk and to realise the potential of government trade policy, including the smooth facilitation of legitimate goods. Improving cooperation between Customs, the private sector and other border and law enforcement agencies is necessary if the aforementioned objectives are to be achieved.

In addition to its engagement within the Region through the Asia/Pacific Vice-Chair and WCO Members through the Asia/Pacific Customs Region, the RPSG A/P also engages directly within the WCO through its affiliation with the WCO Private Sector Consultative Group (PSCG) and participates in various meetings and working groups in Brussels in order to advance these objectives.

SPOTLIGHT FROM THE EDITOR Embedding Economic Resilience in the Pacific Customs has an important role as the collectors of the revenue governments use to pay for public services

Tariff revenue from imported goods represents a significant proportion of government revenue in Pacific countries. In Samoa for example, over half the government revenue is collected by Samoa Customs in the form of tariff and excise duties, and Value Added Goods and Services Tax. This makes effective revenue collection functions crucial to the health of Pacific Island economies. Without it, governments could miss out on vital funds.

This is where the New Zealand Customs Service (NZCS) can offer support. The agency is providing advice and technical assistance to Pacific Customs partners to assist them on their pathway to modernisation and longer-term economic resilience, through the Customs Sector Development Programme.

This Programme aims to increase Pacific Island economic prosperity, as well as leadership development and border security, through building capability across the Region's Customs administrations. It is funded and supported by New Zealand's Ministry of Foreign Affairs and Trade.

Revenue collection in Vanuatu

NZCS Senior Policy Analyst, Colin Brown, has been working with the Vanuatu Department of Customs and Inland Revenue since 2019.

"We have been providing revenue support to Vanuatu Customs through targeted audit work. Vanuatu Customs officers were trained on how to use data analysis to identify systemic undervaluation and revenue fraud, which presented opportunities to significantly increase revenue."

"This work has had clear results, with a number of instances of fraud and undervaluation detected as a direct result of the training, as well as a notable increase in the revenue that's been collected."

In December 2023, Vanuatu Customs announced a record revenue collection of 2 billion Vt (approx. USD \$16.9 million). Of this, five percent (approx. USD \$850,000) was identified as additional revenue collected by Vanuatu Customs' compliance audit team.





"Vanuatu Customs acknowledged this was a direct result of the support provided by New Zealand Customs," Mr Brown said.

Other areas of work with Vanuatu have included assistance towards improved border targeting, post-clearance audits, and the correct classification of goods by Customs officials and Industry stakeholders. Currently both agencies are developing a strategy to share information to improve importer compliance levels in Vanuatu.

"By helping to upskill Pacific partners in revenue collection, we can support greater economic security and stability in our region," noted Mr Brown.

Sugary drinks in the Cook Islands

The Cook Islands Customs Service (CICS) has identified cases where the excise tax on sugary drinks was being evaded.

Importers were identified as falsely declaring fruit drinks – which typically contain only 25 percent fruit juice, in addition to water, sugar, and additives, such as flavourings – as pure fruit juice, which is not subject to excise.

It wasn't possible to determine from the submitted data the quantity of fruit drinks being falsely declared as fruit juice. Unless the importer includes the full brand and product description on the declaration, which is not mandatory, CICS could not distinguish whether the goods imported were pure fruit juice or a fruit drink subject to excise.

To address this, NZCS is working with CICS to educate importers on the correct excise duty classification and to notify them that Customs will be monitoring imports of fruit juice to ensure compliance.

NZCS is providing continuing support to the CICS as they work to collect the correct amount of revenue on imported fruit drinks.


Mr Brown added, "Effective revenue collection is essential for economic development and strengthening public services. By collaborating with Pacific partners in this area, we can support greater economic security and stability in our region".





The Australian Border Force (ABF), in its capacity as the World Customs Organization (WCO) Asia/Pacific Vice-Chair (APVC), in cooperation with WCO Customs Operational Practices for Enforcement and Seizures (COPES), the Asia/Pacific Regional Office for Capacity Building (ROCB A/P) and with sponsorship by Japan Customs, hosted the WCO Asia/Pacific Region Digital Forensics Workshop in Perth, Australia, from 17-21 October 2022.

The 2023 WCO Asia/Pacific Operation TENTACLE AML/CTF Workshop

"Customs agencies are indispensable in the whole-of-government effort to tackle the scourge of money laundering" ABF Commissioner Outram said during his opening address at the WCO AML/CTF Workshop in Brisbane



The 2023 World Customs Organization (WCO) Operation TENTACLE Anti-Money Laundering (AML) and Counter Terrorism Financing (CTF) Workshop was hosted by the Australian Border Force (ABF) in collaboration with the WCO AML/CTF Programme and staff from Operation TENTACLE in Brisbane from 27 February to 3 March 2023. It was attended by 62 representatives from 23 countries from the Asia/Pacific alongside Australia's money laundering regulator AUSTRAC, and global authorities INTERPOL and the Egmont Group of Financial Intelligence Units.

The Workshop raised awareness of the prolific threat of money laundering and terrorism financing and reinforced the critical role of Customs in anti-money laundering efforts. The workshop provided a valuable opportunity for Customs and partner agencies to deepen understanding of the complex challenges posed by money laundering and terrorism financing.

In an opening address in his capacity as the Asia/Pacific Vice-Chair, ABF Commissioner and Comptroller-General of Customs Mr Michael Outram APM emphasised the importance of the role of Customs in the fight against transnational serious organised crime.

Criminals "infiltrate every aspect of our Supply Chains, using methods that include trade-based money laundering and bulk cash smuggling, to move hidden value across our borders. Working alongside key partners, Customs agencies are able to reduce the influence of crime and ultimately protect our communities from harm."

"Improving the capacity for Customs agencies to deliver anti-money laundering enforcement will lead to a commensurate strengthening of national, regional and international security. Our collective role, both nationally and regionally, underpins our overall responsibility to safeguard our communities from the effects of illicit value transfer."

Commissioner Outram expressed his gratitude to the US Department of State – Bureau of International Narcotics and Law Enforcement Affairs for their exceptional leadership and financial support initiatives of WCO Operation TENTACLE, including for the Workshop.

The World Customs Organization (WCO) Asia/Pacific Plastic Waste (APPW) Project was a regional initiative held between the WCO and WCO Member Customs administrations in the Asia/Pacific between April 2020 to June 2023.

The Project was funded by the Government of Japan and was attended by Customs administrations from Cambodia, Indonesia, Laos, Malaysia, the Philippines, Sri Lanka, Thailand and Vietnam to strengthen their capacity to prevent the illegal or unregulated cross-border trade in plastic waste and to promote sustainable waste management practices. The Australian Border Force also participated as an observer.

The Project culminated in the concluding High-Level Workshop held in conjunction with the 24th Regional Heads of Customs Administrations (RHCA) Conference held in Perth, Australia over 28-31 April 2024, where the WCO and participants of the APPW Project presented on the outcomes of the multi-year effort and a number of recommendations to help ensure the Region maintains its attention and leadership on this increasingly important global and regional challenge. At the 24th RHCA, WCO Members of the Asia/Pacific Customs Region moved to incorporate the focus of the APPW Project as a standing meeting agenda item in the annual RHCA, with participants to update Members on their continuing efforts.

The event, which included over 100 participants from the Americas and Caribbean and Asia/Pacific Regions, aimed to break down barriers and inspire each other to achieve equality and inclusivity in our own Customs administrations.

Notwithstanding the challenges that persist in modern societies, both the Americas and Caribbean and Asia/Pacific Regions have made significant strides in promoting gender equality and diversity over recent years through a number of initiatives across the leadership, recruitment and workforce policy spectrums. These efforts have helped to increase the representation of women in

Customs roles from the frontline to senior executive positions.

Members from the two Regions shared their experiences, best practices and lessons learned through a number of presentations and group discussions. Presenters from Chile and Colombia on the one hand and from Cambodia's General Department of Customs and Excise and the New Zealand Customs Service on the other, each shared their updates on developments, efforts and successes on behalf of their respective Regions.

The Workshop inspired the participants to continue to look for ways to advance gender equality and diversity in their own Customs administrations, noting that by creating a diverse workforce, Customs can drive greater innovation, effectiveness, and resilience in the face of evolving challenges and opportunities.
